See the following detailed policies for attendee registration to the 29th Annual 2026 NPPA Conference, this August 17-20 at Horseshoe Las Vegas hotel in Nevada. The National Pharmacy Purchasing Association (NPPA) focuses on the pharmacy buyer.

Save or print this information as needed for reference, to get advance approval to attend from your supervisor or facility, or to include in paperwork for your facility's accounts payable department with your registration invoice. Note if you've requested to be billed on a facility Purchase Order (PO), your accounts payable dept. need to be aware of the increased pricing after our early-bird expiration date and other payment deadlines.

REGISTRATION FEES & DEADLINES

Early-Bird Deadline – May 7

After this date (May 7, 2026), all registration fees will **increase** by \$40—including if you've already submitted a registration on a Purchase Order or check in process but your payment has not been received at the NPPA offices by that date. If your Purchase Order is still pending payment after the early-bird deadline, the higher registration fee will then be due. Adding a note about the rate increase and deadline with your Purchase Order before submitting to your facility is helpful.

2026 NPPA Conference Attendee Registration Policies (page 2 of 5)

After Pre-Reg Deadline August 14—Onsite/In-Person Registration *ONLY* (additional \$20)

After the final August 14 deadline, online pre-registration will close and any remaining payments due must be applied in full through the link in your confirmation email (see “Outstanding Payments Due” on page 4). However, after that time you can still register **in-person onsite**, with an additional **\$20 onsite fee**. Onsite registration at Horseshoe hotel in Las Vegas is handled at NPPA’s attendee registration desks on the following dates and locations: Monday August 17 from 4:30pm to 6:00pm at SkyView rooms 5-6 on the 26th floor; and Tuesday August 18 at the ground level Grand Salon from approx. 7:15am to 8:20am (when breakfast is also provided and before the educational lectures begin around 8:30am).

Although onsite registration in Las Vegas is allowed, we still ask you to **contact NPPA as soon as you know of your travel plans** to join us, even if you don’t have time to pre-register online. Being aware of your plans beforehand greatly helps NPPA to prepare and bring enough program materials for all attendees, as well as to best provide our final numbers with the hotel for the room set-up and meal counts.

Status of NPPA Membership with Discounted NPPA Member-Registration Fee

After a new registration has been submitted, the NPPA staff will review the fee you've chosen along with your current NPPA membership status, to confirm it is either new or will remain current through August 2026 (the conference month), to qualify for the lower member-registration fee. If membership needs to be added or renewed, NPPA will contact you with options to fully complete your registration.

Additional Discounts Available for Attendee Registration (Coupon Codes)

The following discounts *may be* applicable for your attendee registration fee—however, you will first need to contact the NPPA office to check your eligibility for these discounts before completing your registration. If you think you may be eligible for one of these discounts and have already started the registration process, please choose “Save & Continue Later” before completing it all and reach out to NPPA from there. Once confirmed, NPPA will provide you with the discount to apply when on the Payment page, the final part of the registration process, where you'll see an option to add a “Coupon Code”.

- 1) **The 2nd Attendee** to register from a *single facility address* is eligible for a discount of **\$10.00** (*only for the 2nd Attendee*). Contact NPPA to confirm your status and get the appropriate code.
- 2) **Participating GPO Companies** may be entitled to additional discounts for their company's executives, based on their current & previous year's agreement and participation with NPPA. For details, check with your company's main contact, or NPPA directly.

Speakers & Scholarship Awardees

If you are a potential or confirmed speaker or have officially been awarded one of our Scholarships for your registration fee, please save your registration before choosing a payment option by using the “Save & Continue Later” button during the process and contact the NPPA office for assistance from there.

Guest Passes For Attendee Opening Reception (Monday, August 17)

Guest passes for friends/spouses to join pharmacy attendees at NPPA's Opening Reception on Monday August 17 are available for an additional \$60. Guests must not be involved with the NPPA Conference nor employed by a pharmacy, hospital, or drug company. To order a guest pass, contact the NPPA office to request an order/agreement form, which will be paid for separately after NPPA approval. Limited to one guest (21 and older) per attendee. Guest passes must be requested by the end of day on August 5.

BILLING & PAYMENTS

Purchase Orders:

- **Paying with a Purchase Order (PO)** for an NPPA attendee registration fee implies intent to pay in full. If you requested to pay on a PO before our early-bird deadline of June 3 and your payment has not been received at the NPPA offices or paid by credit card in your online registration account by that date (when the Registration Fee increases), a newly updated invoice will be emailed that shows the new registration fee amount due (after the early-bird deadline).
- **After July 16, through Advance Registration Deadline:** PO's will *no longer* be accepted. After July 16, all payments must be made either by credit card through the advance registration deadline of August 14 (see "Pre-Reg Deadline" section above); or by check if it is sure to arrive to the NPPA offices before August 12, when we will then be on our way to Las Vegas.

Outstanding Payments Due:

- **Payments by Check** (on PO or otherwise) must be received at the NPPA offices *no later than August 12*. After that date, NPPA staff will already be on their way to Las Vegas.
- **Payments by Credit Card** may be made to your online registration (through the link in your confirmation email), no later than **August 14** at 7:00pm Pacific Time. After this time, payments must be made *onsite in Vegas*, by credit card, cash, or company/facility checks (no personal checks accepted onsite).

Refunds/Cancellations

Cancellations must be requested in writing (via email, to Info@PharmacyPurchasing.com). All registration fees paid in full that are cancelled by June 16, 2026, will be refunded 100%. Cancellations between June 17, 2026 through July 16, 2026 will receive a 50% refund on their registration fees. *After July 16, 2026*, refunds *will no longer* be available.
